# ADRODDIAD SCAA SBAR REPORT

## Sefyllfa / Situation

Hywel Dda University Health Board (HDdUHB) is a statutory member of Public Services Boards (PSBs) in Carmarthenshire, Ceredigion and Pembrokeshire and the West Wales Regional Partnership Board (RPB).

The purpose of this report is to provide an update to the Board in respect of the recent work of the three PSBs and the Regional Partnership Board.

## Cefndir / Background

PSBs were established under the Well-being of Future Generations (Wales) Act 2015 (the Act), with the purpose of improving the economic, social, environmental and cultural well-being of populations within their geographic areas by strengthening joint working across all public services in Wales.

The effective working of PSBs is subject to overview and scrutiny by the Well-being of Future Generations Commissioner and Audit Wales, as well as by designated Local Authority overview and scrutiny committees.

Regional Partnership Boards, based on Local Health Board footprints, became a legislative requirement under Part 9 of the Social Services and Wellbeing (Wales) Act 2014 (SSWBWA). Their core remit is to promote and drive the transformation and integration of health and social care within their areas.

#### Asesiad / Assessment

## **Well-being Assessments and Population Assessments**

The publication of a PSB Well-being Assessment and RPB Population Needs Assessment are requirements of the Well-being of Future Generations (Wales) Act 2015, and Social Services and Well-being (Wales) Act 2014, respectively. Effectively involving people and

communities is at the heart of improving well-being, therefore, engagement and consultation has been one of the key drivers during this round of assessments.

The three PSBs and the RPB have worked collaboratively on the Well-being Assessment and Population Assessments, using a Regional Engagement and Consultation Framework to provide a standardised approach to conducting the engagement and consultation activity. The regional survey was translated into a number of community languages and actively promoted by the Health Board's Community Development Outreach Team who are working specifically with minority ethnic communities and those who face barriers to accessing health care provision e.g. those who are homeless.

The Health Board has been represented at the regional working groups taking forward this work in conjunction with the three PSBs and the RPB. As part of its commitment, the Local Public Health Team and Strategic Partnership, Diversity and Inclusion Team undertook analysis of the health and well-being questions within the Well-being Survey. The analysis of the findings will be incorporated into the first set of draft Assessments which are due to be presented to PSBs at their meetings in November 2021.

All PSB Well-being Assessments and the RPB Population Assessment will be presented to the Strategic Development and Operational Delivery Committee on 24<sup>th</sup> February 2022, prior to presentation to Board for approval on 31<sup>st</sup> March 2022.

# Regional Partnership Board (RPB) Update

The RPB met on 22<sup>nd</sup> October 2022. The meeting was attended by the Children's

Commissioner for Wales, who is visiting all RPBs over the Autumn to check regions' progress in taking forward the children's agenda, particularly the development of seamless services for children and young people with complex needs as set out in her 2020 report 'No Wrong Door: Bringing Services Together to Meet Children's Needs' and the role of the RPB in coordinating improvements across services. Colleagues highlighted progress in a number of areas, including:

- Creation of a regional Children and Young People's Group sitting under the RPB
- Progression of a new service model to provide trauma-informed care to children with high end mental health and emotional needs, supported by step-down accommodation across the region to repatriate children and young people placed out of region and support their return to the community
- Early work on implementing the <u>NYTH/ NEST</u> framework to support children and young people and their families with a range of needs
- Work on the establishment of regional commissioning arrangements for complex needs
- Local initiatives to involve children and young people in the development and delivery
  of services, which partners aim to consolidate into regional approaches moving
  forward. The Chair and Vice Chair of the RPB will also attend a national session in late
  November, facilitated by the Children's Commissioner, her young advisory panel, the
  National Youth Stakeholder group for mental health and the Together for Children and
  Young People (2) programme to discuss a whole system approach to children's mental
  health and wellbeing and how children and young people might contribute to the work
  of RPBs
- Improvements in provision for children and families in crisis
- Explicit commitment of the RPB to maintain a focus on children's issues and support the transformation and integration of services, using new Welsh Government funding to support this

The Commissioner welcomed these developments and, whilst acknowledging that local variation in delivery arrangements is to be expected given the nature of the West Wales region, emphasised the value of consistent service models and the role of the RPB in supporting the development of these. She also recommended that initiatives being taken forward by individual partners, for example a review of emotional and mental health services in Pembrokeshire and the establishment of a multi-disciplinary group within Hywel Dda UHB to take forward the No Wrong Door recommendations, should be adopted across the Partnership.

Specific observations and recommendations for West Wales will be prepared and shared with the RPB following the Commissioner's visit.

At its meeting the RPB also considered:

- The integrated approach being taken through the Health and Social Care Tactical Group to respond to current system pressures and initiatives being taken forward to mitigate their effects, for example the new Home Based Bridging Service
- Progress in relation to the development of the Population Assessment and Market Stability Report for West Wales, which will be completed by the end of the calendar year and signed off by partners in the early part of 2022
- Highlights of the Healthier West Wales (Transformation Fund) programme and initiatives supported by the Integrated Care Fund

It was noted that Welsh Government was expected to issue advice on next steps in relation

to the 'Rebalancing Care and Support' White Paper shortly; this would reflect the responses to the consultation undertaken earlier in the year and the implications of additional resources made available to support the sector following the UK Government's recent announcement of increased investment from March 2022.

An update was also provided on new revenue funding arrangements for RPBs from March 2022. Details of these arrangements are still being worked through by Welsh Government in close cooperation with a range of stakeholders, including RPB leads, Directors of Social Services, system leaders via the Welsh NHS Confederation and Welsh Local Government Association and LHB and Local Authority Directors of Finance, with a view to issuing guidance during November 2021. Indicative regional allocations have yet to be confirmed but are expected to be on the basis of population and be broadly commensurate with current funding levels.

What is known at this stage is that:

- Proposals will need to be based on evidenced business cases and reflect one or more of the following national priorities:
  - o Prevention/ health promotion
  - Place based community care
  - o Promoting good mental health and wellbeing
  - Preventing children entering care and supporting children to remain with their families
  - Home from hospital
  - Accommodation-based solutions
- Three principal funding streams will be available: (1) a new Regional Support Fund (RSF) providing ring-fenced resources for delivery of the statutory RPB function (in West Wales via the Regional Partnership Unit); (2) a New Model Development Fund (NMDF) to support innovation/ proof of concept projects and (3) a National Embedding Fund (NEF) to support established projects requiring ongoing support to embed models within the system
- Allocations will be conditional on partners providing match funding; required levels will be different for the RSF (25%), NMDF (10%) and NEF (30%)
- Minimum percentage investments will be set for social value sector (20%), CYP on edge of care/ care experienced (14%), Direct support for Carers (5%) and engagement (percentage not yet confirmed)
- National ringfenced funding will remain to support Dementia, the Integrated Autism Service and Early Years/ Prevention

Regionally, work is underway to develop regional proposals by late 2021 for submission. This is being taken forward in two phases:

Phase 1 (Completion by mid-November 2021)

Review of existing funded projects to ascertain:

- Which projects are likely to be put forward for new funding based on available evidence
- Likely requirements in terms of funding and the relevant future funding stream that a
  project may align to (including consideration of any match funding requirement)
- Those that should be mainstreamed
- Those that need to be decommissioned (with identification and mitigation of associated risks)

New areas of activity for which funding might be sought

Separate consideration will be given to the RSF and how this will be deployed to support the Regional Partnership Unit and associated activities.

#### Phase 2 (From mid-November 2021)

Findings from the above exercise will be brought together into facilitated discussion/s on the shape of the new regional programme, needs to start soon after with a view to completing the exercise by mid-December 2021. This discussion will also take into account:

- The case for refocusing existing programmes including new arrangements for existing TF projects
- Findings emerging from the Population Assessment and Market Stability Reports
- Alignment with other funding such as Clusters and Same Day Emergency Care (SDEC)

Arrangements for delivering this second stage are being discussed with system leaders and will be confirmed shortly.

Parallel discussions are also underway regarding successor Capital funding which will replace the current ICF Capital fund.
