Sefyllfa / Situation

The Radiology Informatics System Procurement (RISP) Programme was set up in 2019 to procure and modernise a replacement Picture Archiving & Communication System (PACS), Radiology Informatics System (RIS) and Patient Dose Monitoring System (PDMS) for all Health Boards and Trusts in Wales. The Programme is supported by a small Programme Management Office comprising of seven staff, that was hosted by the NHS Collaborative until 1 January 2023, when it transferred to Digital Health and Care Wales (DHCW).

The RIS is used to record patient demographic details and manage the appointment process. Following the completion of an x-ray or scan, the images are stored in a digital format in PACS, which is then used to manage the clinical reporting process and to display the images and reports for clinicians outside of radiology to review.

This report is being brought to the Board for information, to update on the major RIS and PACS replacement project within Hywel Dda University Health Board (HDdUHB).

Cefndir / Background

The current Health Board (HB) PACS has been operating since 2013 and had an initial contract end date of March 2025. The administration of the all Wales RISP project is complex, has encountered delays resulting in slippage of timelines and the implementation date from January 2025 to July 2025 for the HB. This has required HB negotiation with DHCW, the incumbent suppliers and new RISP supplier, to ensure service continuity during the replacement programme. The current timelines for going live with the new RISP supplier PACS, RIS and PDMS systems is July 2025. The contract awarded to the new RISP supplier is for a period of five years with an option to extend for a further two years. It is important to note that HDdUHB will be the sixth organisation in Wales to implement the new systems and so further slippage could occur due to delays incurred by the earlier implementing organisations, delaying the implementation of the system for reasons which are outside of the control of the HB.

An Outline Business Case (OBC) for the RISP programme was signed off by all HBs in 2022. The Full Business Case (FBC) was approved by all Executive Boards by the revised deadline of July 2023 and the key risks were highlighted to the HDdUHB Board in the FBC paper which was presented to the Public Board meeting on 25 May 2023. The challenging implementation timelines and risks were becoming an increasing cause for concern and were highlighted by HBs to DHCW. The potential of non-delivery of the RISP Programme within HDdUHB risks the HB being left in a position whereby there is no functioning PACS system after the agreed incumbent supplier contract end date of March 2025 and therefore no HB wide radiology service. Due to commercial sensitivities at this time, a paper regarding this issue along with options for providing the HB with a viable contingency plan was presented to the In-Committee Health Board Meeting on 27 July 2023. The Head of Radiology and the HB Digital Director appraised the options presented by DHCW and advised the In-Committee Board that the preferred and only realistic option to ensure safe service continuity, would be to extend the current PACS contract with incumbent supplier. This option would ensure that the HB implementation would remaining as close as possible to the original implementation date to realise the clinical and operational benefits of these systems, whilst providing a contingency in the event of further slippage of project timelines. An additional benefit of the incumbent supplier contract extension is that the computed radiography legacy equipment would be supported until the end of the incumbent supplier contract and would allow more time for digital replacements or a digitising solution to be found which is an additional cost and risk to the HB.

At the In-Committee Board meeting on 27 July 2023, approval was given for the preferred contract extension option, which was a four year extension with the incumbent supplier, however agreement has been reached for a three year contract, so reducing the additional costs incurred by the HB. This subsequent change in length of contract was presented to the In-Committee session of the Sustainable Resources Committee on 29 August 2023.

A summary of this complex situation along with an audit of the financial position at each stage can be seen below:

Asesiad / Assessment

To date, the following key milestones have been achieved:

- A Hywel Dda Local Implementation Group is being initiated.
- The all Wales Deployment Order was signed by HDdUHB and returned to DHCW on 17 August 2023.
- DHCW shared the revised integration plan with all organisations on 23 August 2023.
- On 1 September 2023, HDdUHB signed and returned the 3 year contract extension with the incumbent supplier to run from 1 September 2023 to 31 August 2026. The additional cost to the HB for this extension are explained as follows:
 - The original incumbent supplier contract was due to end on 31 March 2025, with the new RISP supplier go live date being January 2025.
 - The new contract is for a period of 3yrs (fixed term), will commence on 1 September 2023 and will run until August 2026. Therefore, the actual extension to what is already agreed in the original contract is for the period from 1 April 2025 until 31 August 2026 (17 months).
 - The HB was advised by DHCW on 1 September 2023 that the new RISP supplier implementation dates and milestones for HDdUHB are currently as follows:
 - New RISP supplier go live date 1 July 2025
 - New RISP supplier stable operation date 31 July 2025
 - At this time, based on the above information, the actual additional costs to the HB for this extension would be at the point that we reach stable operations with new RISP supplier and start to pay dual running costs until the end of the contract with the incumbent supplier. Currently this is expected to be expected to be from 1 August 2025 to 31 August 2026 (incumbent supplier final end date), a period of 13 months. The additional costs to the HB is expected to be approximately £780k ex VAT.
 - It is important to note that any slippage of the new RISP supplier stable operations date will reduce these costs further.
- Planned work to be carried out next period:
 - Agreement on revised dates by all HBs. The Head of Radiology advised the RISP Programme Board Meeting on 30 August that HDdUHB would not be prepared to agree to moving the planned implementation date any later than July 2023 but would potentially move to an earlier date if required.
 - Signing of the Master Services agreement.
 - Signing of the Local Deployment Order agreement
 - Re-establish the local implementation group, to provide governance and adoption of the system.
